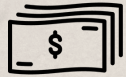

What is the St. John Endowment Fund?

The St. John Endowment Fund provides a unique opportunity to express gratitude to God for the blessings we have received. Gifts and bequests made to the Endowment Fund allow you to share the transforming grace and power of Jesus Christ with others, both during and beyond your lifetime.

How is giving to the Endowment Fund different from other giving?

Unlike tithing that supports the St. John general fund or over and above giving to the capital fund, the endowment fund provides an opportunity for legacy gifts. Donations to the endowment fund are placed in an investment portfolio in order to enhance St. John's outreach for years to come.



How can I give to the Endowment Fund?

There are many ways to give tax-deductible donations to the Endowment Fund including:

Who manages and oversees the Endowment Fund?

Thrivent, a not-for-profit financial services organization founded by Lutherans, manages the fund for St. John. An Endowment Fund Committee, established by the St. John Board of Directors, oversees the Fund and makes recommendations when distributions are requested.

What are Tribute Gifts?

You can give any amount and designate it as a Tribute Gift. Tribute Gifts are a way to celebrate, give in memory of or honor a friend or family member or recognize a special event or occasion. For gifts of \$2,500 or more, you can request a leaf be engraved with your designated tribute and placed on the Jeremiah Tree located in the lobby of the church.
