

## CCP Registration 2024/2025 School Year

### Registration for New Families

Registration for the 2024-2025 school year begins for families who are new to CCP on Monday, February 12<sup>th</sup> at 8:55am. Applications must be turned in in-person.

**Interested registrants may form a line as early as they wish but applications will not be accepted until 8:55am and will be accepted on a first come, first serve basis.** Applications cannot be accepted before the 12<sup>th</sup>. The non-refundable registration fee of \$75 per family is due at the time of registration and may be paid by cash or check. The attached class preference form should be fully filled out and turned in with your \$75 fee.

Students will be placed in classes in the order in which their registration is received. If your first-choice class is full you will be notified within 24 hours. You will be put on the wait list for your first choice. If you decide you do not want the second-choice class or to be put on the wait list, your registration fee will be refunded.

**Please note: enrollment for current students and siblings takes place prior to open enrollment for new families so spots (especially in the 3s and 4s) are extremely limited. Many of our grade levels have the exact number of spots available as children eligible to move up from the younger class.**

Once your student is assigned a class, you will be sent a registration form via Brightwheel. It must be filled out no later than February 29<sup>th</sup>.

The per child \$50 supply fee will be assigned at registration but is not due until August 1, 2024. September tuition will also be due on August 1st. October tuition will be due by September 1<sup>st</sup> and the last payment of the year will be April 1<sup>st</sup> for the month of May.

### Classes and Rates for 2024/2025

Toddler Class (age 12 mos. by Aug. 31, 2024): 3 days (MWF) \*must be walking confidently

2-year-old Class (age 2 by Aug. 31, 2024): 2 days (T/TH), 3 days (MWF) or 5 days (M-F)

3-year-old Class (age 3 by Aug. 31, 2024): 3 days (MWF) or 5 days (M-F)

4-year-old Pre-K Class (age 4 by Aug. 31, 2024): 4 days (M-Th) or 5 days (M-F) \*must be fully potty-trained

#### Toddlers, 2s and 3s Class Rates:

2 days (T/TH): \$219.50 per month

3 days (MWF): \$275.50 per month

5 days (M-F): \$367 per month

#### 4-year-old Pre-K Class Rates:

4 days: \$321.50 per month

5 days: \$377 per month

\*Rates are based on a full school year, divided by 9 months.
