is started and may require professional help. I am responsible for any and all costs of repairs, regardless of what caused the  
damage.

\_\_\_\_\_ As consideration for allowing the Missional Men's Ministry team to perform their acts of service, I forever release  
the Missional Men's Ministry, ChristWay Community Church, elders, directors, employees, volunteers, agents and  
representatives (collectively "releases") from any and all actions, claims, or demands that I, my assignees, heirs, guardians,  
next of kin, spouse and legal representatives now have, or may have in the future, for injury, death or property damage, related  
to their services, their negligence or other acts, whether directly connected to these services or not and however caused, or  
the condition of the premises where these activities occur, whether or not I am then participating in the activities.

\_\_\_\_\_ I also agree that I, my assignees, heirs, guardians, next of kin, spouse and legal representatives will not make a claim  
against, sue or claim false representation for any and all repairs done.

\_\_\_\_\_ I understand that ChristWay, its employees or participants in this ministry may take photographs, images, video or  
audio recordings at the Worksite. I hereby grant and convey to ChristWay all right, title and interest in any photographs,  
images, video or audio recordings that ChristWay, its employees or participants in this ministry obtained from Worksite. I  
further:

\_\_\_\_\_ I expressly agree that this Waiver shall be governed by the laws of the State of Tennessee, and that venue of any  
action shall be in the courts of Hamilton County, Tennessee. I agree that if any clause or provision of this Waiver is deemed  
invalid, that the enforceability of the remaining provisions of this Waiver shall not be affected.
