Permission & Waiver of Liability

Programs & Activities. Missional Men is a Ministry of ChristWay Community Church ("ChristWay") that seeks to care for ChristWay's neighbors (hereinafter "Homeowners") through repairs or by the installation of certain improvements, such as wheelchair ramps, to Homeowner's homes. It is my understanding that participating in the Missional Men Ministry with ChristWay is a privilege. Prior to participation in such activities, I acknowledge that there are certain risks associated with the activities, including, injury, illness, death, or property damage. In addition, I acknowledge that there may be other risks inherent in these activities of which I may not be presently aware.

Release of Liability. By signing this Permission & Waiver of Liability form (hereinafter "Waiver"), I acknowledge that I am aware of the physical and mental demands of the Missional Men activities, and I (or minor participant) am capable of participating in these activities. I understand that the services provided by me to ChristWay and Homeowners may include activities that are inherently dangerous, including a risk of injury, illness, death or property damage. I hereby assume the risk of injury **to me, minor participant or my property** from these activities and release ChristWay, its elders, staff members, leaders, employees, volunteers, and agents, as well as Homeowners, from all liability for injury, illness, death or property damages resulting from the services I provide as a volunteer or occurring while I am participating in activities.

Aid and Emergency Medical Treatment. I recognize that there may be occasions where first aid or emergency medical treatment as a result of an accident, illness, or other health condition or injury may be needed. I do hereby give permission for ChristWay, its elders, staff members leaders, employees, volunteers and agents, to seek and secure any needed medical attention or treatment, including hospitalization, if in the agent's opinion such need arises for myself or minor participant. I agree to pay all fees and costs arising from this action to obtain medical treatment. I give permission for attending physician(s) and other medical personnel to administer any needed medical treatment, including surgery.

Code of Conduct. I agree to participate in the functions and activities of ChristWay, to cooperate with the leaders and participants, and to conduct myself as an example of Christ at all times. I promise to respect God, respect myself, respect other persons, and respect property. I understand that my continued participation in church activities depends on my consent of this Waiver. In addition, I have read and fully understand the entire contents of this Waiver.

Photographic Release. I hereby acknowledge that ChristWay, its elders, staff members, leaders, employees, volunteers or agents may create or generate photographs, images, video and/or audio recordings (collectively “Media”) of me participating in these activities, and that this Media may capture my likeness or voice. I grant and convey all right, title, and interests to Media containing my likeness or voice to ChristWay, including any royalties, proceeds, or other benefits derived from such media.

Other. I expressly agree that this Waiver shall be governed by the laws of the State of Tennessee, and that venue of any action shall be in the courts of Hamilton County, Tennessee. I agree that if any clause or provision of this Waiver is deemed invalid, that the enforceability of the remaining provisions of this Waiver shall not be affected.

By signing below, participant agrees to the above terms and conditions. Minor participants by their signature do not waive any substantive legal rights, but are acknowledging their adherence to the Code of Conduct.
