#### SUPPLY / ACTIVITY FEE

These funds support our summer program's variable curriculum expenditures including but not limited to enrichment classes, art mediums, craft materials, classroom supplies, wipes, perishable sensory items, special seasonal projects, lamination, and First Aid.

#### SAFETY & SECURITY FEE

These funds support our campus security guard and visitor management system. The Safety & Security Fee is listed on the Payment Schedule and will be billed accordingly.

#### PAYMENT SCHEDULE

- Registration – due at Time of Enrollment
- Payment 1 – due April 1, 2026
- Payment 2 – due June 1, 2026
- Supply Fee – due May 15, 2026
- Safety & Security Fee – due May 15, 2026

#### WITHDRAWAL REQUIREMENTS & REFUND POLICY

Students withdrawn from the Summer Program *prior to the first day of school* MUST submit written notice to the Main Office by the date listed below to be eligible for:

- Registration Fee is NON-REFUNDABLE once paid at **Time of Enrollment**.
- Payment 1 is due **April 1, 2026** and is Non-Refundable after that date.
- Payment 2 is still DUE on **June 1, 2026** when written notice is received after **April 1, 2026**.
- All monies paid towards Registration Fee, Payment 1 and Payment 2 are Non-Refundable when written notice is received **after April 1, 2026**.
- Supply Fee is Non-Refundable once paid.
- Safety & Security Fee is Non-Refundable once paid.
- *Tuition and fees are not transferrable to any other students or family members.*

## 2026 Summer Program Payment Schedule

### TUITION & FEES

Enrollment in the Summer Program requires financial commitment to the entire summer session based on “in-session” weeks divided into two equal payments: **Payment 1** and **Payment 2**. See Payment Schedule below:

- The Registration Fee of \$250 per child is non-refundable and DUE at **Time of Enrollment**.
- Payment 1 is DUE **April 1, 2026, and is non-refundable after that date.** *If payment is not received by April 1, 2026, your child's enrollment is no longer guaranteed.*
- Payment 2 is DUE **June 1, 2026, and is non-refundable.**
- The Summer Supply Fee is DUE **May 15, 2026.**
- The Safety & Security Fee is DUE **May 15, 2026.**
- Payment 1, Payment 2, Supply Fee, and Safety & Security Fee payments will be processed via an automated payment system.
- A \$25 fee will be assessed for all insufficient funds.
- The summer program runs over an 8-week period with a week off for the July 4<sup>th</sup> holiday.
- Tuition and fees are not transferable to another student.

### PAYMENT
