Tribute to Reverend and Mrs. Raymond Riggs

For the past nine years, Raymond and Winona Riggs have served as the promotional director team for Tennessee Free Will Baptists. Their ministry has included preaching, evangelizing, promoting, singing, playing the organ and piano, writing and editing, planning programs and retreats, counseling, visiting, advising, and encouraging. They have travelled thousands of miles and conducted hundreds of services as they promoted both state and national work in Tennessee.

Under their leadership, support for state and national ministries has increased. For instance, in 1990 Tennessee's share in the gift goals for National Association ministries was \$730,902. But the actual gifts amounted to \$1,047,198. This represents an increase in giving of more than 43% of the suggested goal! This placed Tennessee as the number one state in national support. Certainly, part of the credit for this goes to Brother and Sister Riggs.

Brother Riggs' ministry has been long and colorful. He was ordained to the gospel ministry by the Social Band Association in Arkansas in 1938. That same year, he served as the church planter and first pastor of the Highland Park Free Will Baptist Church (now the Central Church in Royal Oak, Michigan.)

After an outstandingly successful pastorate at the Highland Park Church for sixteen years, he resigned to become the first full-time Director of Free Will Baptist Foreign Missions (after having served in this capacity on a part-time basis). During his six years in this position, the foundation and basic philosophy were laid for the present foreign missions outreach. It was under his direction that the ministry was enlarged in India and Cuba, and the missions thrust was begun in Africa and Brazil. For many years Brother Riggs served as a member of the Foreign Missions Board, when he was not employed as the director. Perhaps there is no one man among us who has done more for the outreach of the gospel to the "regions beyond" than Brother Riggs. To many of us, he will be "Mr. Foreign Missions" as long as he lives.

In 1959, Brother Riggs organized and pastored the Bethany Free Will Baptist Church in Norfolk, Virginia. In 1967, he returned to the Central Church in Michigan for nine years, making a total of 25 years of pastoral ministry there. Other pastorates included Cookeville Church in Cookeville, Tennessee and the Good Springs Church, just north of Nashville. He entered full-time evangelism and promotion in 1982.

Brother Raymond and Sister Winona have made an excellent team, both musically and otherwise. During their pastorates, Sister Riggs was a very effective musician. She also held various other offices, such as youth director and church secretary.

The Riggs' have six children, all of whom attended Free



Will Baptist Bible College. All four of the sons are ordained. Charles Riggs is an ordained deacon and minister of music, Dr. Kenneth Riggs is Chairman of the Teacher Education Department at Free Will Baptist Bible College and is pastoring Sylvan Park Church in Nashville, Randall Riggs is pastoring the Bethany Free Will Baptist Church in Norfolk, Virginia, and Stephen is serving the Foreign Missions Department as a missionary to France. The daughters are both active in local churches. Ramona works for National Business College in Roanoke, Virginia and Patsy works at Vanderbilt Medical Center in Nashville. Patsy's husband, Bill Daniel, works for the Home Missions Department of the National Association.

The Riggs' have eighteen grandchildren and one greatgrandchild. One grandson is a pastor and one is a medical doctor.

- * Brother Riggs is the son of a Free Will Baptist minister.
- * Sister Riggs is the daughter of a Free Will Baptist minister.
- * The Riggs' have been married for 55 years.
- * Since 1942, Brother Riggs has held an office or has been employed by a department of the National Association of Free Will Baptists.
- * At the present time, Brother Riggs is the Tennessee representative on the General Board of the National Association.
- * Brother Riggs led in the founding of the Liberty Association in the Cookeville area.
- * The Riggs still carry on an effective evangelistic ministry: State Side Evangelism, P.O. Box 49334, Algood, Tennessee 38501 (615/537-9697)

TENNESSEE WOMAN'S AUXILIARY CONVENTION PROCEEDINGS

A total of 82 registered for the 46th annual Tennessee Woman's Auxiliary Convention, November 12, 1991, at Donelson Free Will Baptist Church, Nashville, Tennessee. Speakers Mary Wisehart, Gerald Fender and Laura Thigpen developed the theme "Reaching the Young Woman: Teachers of Good Things."

Delegates were encouraged as the treasurer reported that \$1,295.30 had been received for the state project, which was

\$1,500 for the Gerald Fender account.

Dr. Wisehart reported that a total of \$37,144.08 has been received for the Eunice Edwards Fund. This is \$12,855.92 short of the goal of \$50,000 by December 1991. However, \$35,000 of this has already been given to help build the first Free Will Baptist church building in Spain.

Dr. Wischart reported that in 1990 Free Will Baptist Women gave through WNAC and directly to the missions departments to missions and missions objectives a total of \$520,626.53. That is \$47,112.16 more to missions and related projects than in 1989. Tennessee gave a total of \$26,913.37 and was first in giving to the Co-Laborer Fund and fourth in giving to the Emphasis Offering.

The Woman's Auxiliary Banquet was a great success. Food Sales of Tennessee, represented by Tim Helton, provided the delicious food, which was prepared and served by the Donelson Woman's Auxiliary together with the Donelson teenagers. A gift of \$322.09 was given to the Millington project from the banquet proceeds.

Three Tennessee women won in the Creative Arts Contest. Nancy Harris, Whitesburg, won second place in "Plays." Fannie Ruth Henderson, Greeneville, won second place in "Poetry." Anne Worthington won first place in "Programs."

CHILDREN'S HOME MOTHER'S DAY GIVING FOR CHILDREN

MAY 10, 1992 DATE APPROVED AND SET



The Tennessee State Association gave an extremely warm reception to the latest report from the Free Will Baptist Home for Children. The State Association approved the request to establish an annual fund raising campaign for the FWB Home for Children. This annual project will be held each Mother's Day, beginning May 10, 1992.

MOTHER'S DAY GOAL \$30,000

Funds will go to support our newly established emergency shelter. Our shelter is providing emergency care for children for 30 days or less. During this time we have the opportunity to meet the immediate physical needs of children and evaluate their emotional needs as well. GOAL: to give each child security and stability; for most, it may be the first time. This time of evaluation allows us to determine how we can help the child when at all possible and find placement in our group home facility. This time of adjustment also helps them to become acquainted with their new surroundings and lifestyle. To ask children to come from a possibly violent background or one where there has been no one to supervise their behavior and to live in a house full of eight other children where guidelines are set is very traumatic. They come to us alone, scared, and very angry for the way they have been treated. We are seeing some very positive results since opening the shelter and establishing the evaluation/adjustment period.

National News

Home Missions

A Very Urgent Prayer Request!

Not enough money came in to National Home Missions during September, October, and November to meet the missionary and staff payroll. Some Home Missions staff members in Nashville have not been able to deposit their salary checks because there were not enough funds in the bank to cover them. The Home Missions Department has no debts, but it is simply that income has dropped so drastically this summer and fall that the Department has had to spend \$125,000 more than it has taken in. As of November 1 the home missionary deficits totaled \$91,087.04 and the Home Missions General Fund is \$133,054.59 in the red. These are the largest deficits Home Missions has ever had! The matter is so critical that something must be done to remedy this situation. The National Home Missions Department is asking all-Free Will Baptistindividuals and churches to give generously and consistently to help erase the large deficits. There is good news and bad news from the foreign missions department. The good news is that 70 people made professions of faith recently in an evangelistic campaign in Tanda, Ivory Coast!

More good new: Thanks to our faithful partners in Tennessee the Sexton Walk-a-thon broke another record-- \$124,303! These much-needed funds will help keep our Tennessee missionaries on the field.

The bad news is: Because of severely deficit accounts, four missionaries from other states may be forced to come home and regather their support-- the Baileys, the Owens, the Teagues, and the Wests. The foreign missions board recently instructed the general director to bring any missionary home when his/her deficit exceeds \$8,000. Overall, we estimate that our expenses will exceed our income during 1991 by \$278,000.

We are especially grateful for Tennesse's strong support for foreign missions. Pray for all our people to follow your example.
