PRACTICES Practices for all leagues are scheduled to begin the week of November 6 - 11, 2023.

GAMES Games are scheduled to begin **Saturday**, **December 2**, **2023**.

Generally, participation will be twice each week. Weekday practices or games begin at 5:15 and conclude by 9:30 p.m. Saturday practices or games will begin at 9:00 a.m. and conclude by 8:00 p.m. E, F, G & H Leagues should expect games and practices to be played at the North Campus at <u>2509 Post Oak Tritt</u>. Season ending games will be January 29 – Feb. 3, 2024.
