# Property Report (Andy Askew)

- Property Report 03/06/2025
- Installed a new vanity and sink in the Narthex Restroom.
- Tightened the packing on the 3-way heat valve for the Sanctuary to prevent it from hammering. The valve is associated with the boiler system located in the pit.
- Participated in discussions with the AV engineer on plans for the screens and projectors for the Sanctuary.
- Discussed wiring needs for screens.
- Installation can be completed either 2<sup>nd</sup> week of April or after the Easter holiday.
- Pastor Harrison met with the contractor to close the fence around the trash dumpster. There has been evidence of trash from homes being dumped here, and people have been smoking in the Area. A lock with a code will be installed so that trash pickup can continue without interruption. The total cost to complete this project is \$1400.00.

## Treasurer Report (Nola Mann, reported by Paul Gillespie)

- We have not yet received the February financials. Upon reviewing the January financials, it was discovered that the restroom remodel and the audio speakers for the sanctuary were charged to Property. Danny has been asked to relocate these costs to come out of the Property Major Projects funds that we have accumulated over the last few years instead of showing up as budgeted property expenses. He has yet to send us the revised January financials, which will then show that we are about \$3000 short of covering expenses after one month of the year.
- Going forward, Danny will be instructed on which account expenses should be deducted when information is sent.

### **Elder's Report** (Pastor Harrison)

- The church Elders continue to remain diligent in their commitment to connecting with their assigned members through various forms of communication each month. Their dedication to spiritual care and support is greatly appreciated.
- Due to recent health concerns with Elder Michael, Pastor David will step in to cover communion prayer on the schedule moving forward. Mike will continue making calls to his assigned members as long as possible. Additionally, Pastor David will be available to cover for any Elder who may have scheduling conflicts or cannot serve due to illness.
- This week, a revised prayer schedule will be distributed to the Elders to reflect these
  adjustments. Thank you all for your continued faithfulness in serving the church
  community.
- We still need to add another Elder to the roster.

### Diaconate Report (Adelina Vega)

• The Deacon/ Greeter members are doing well. Adelina and Donna continue to assist those Greeters who need additional support. Recruitment is ongoing.

**Christian Action Report** (Paul Gillespie)

- New Communion We are back with our regular schedule of distributing bags of pantry staples 9 times during the month and bags of food to the homeless once a month. We will soon be planning what our bags will look like for the Easter distribution on Saturday, April 19<sup>th</sup>.
- **Backpack** We continue to pass out 120 bags per week at Easton, with Marc and Wendy Mullins and Ginny Tussey filling in while Lindsey is recovering from surgery on her foot. We have volunteers coming on the morning of April 4th to participate in our next bagging event to finish out what we need to cover the rest of this school year. We have a couple of outside groups who will also help put these bags together.
- Church World Service Sometime between now and Easter, we will be delivering the 202 clean-up buckets and 420 hygiene kits, currently in our choir room, to First Christian/Greensboro, which Church World Service will pick up in early June. These hygiene kits have been provided every year for the last few years.

- Holly Kessler, Director of Engagement for the Forsyth Jail and Prison Ministry, will speak during announcements on Sunday, March 16, 2025, for the youth kickoff of the hygiene kit drive. These kits will be put together by FCC youth; they will participate in subsequent announcements with requests for supplies to be included in these kits.
