

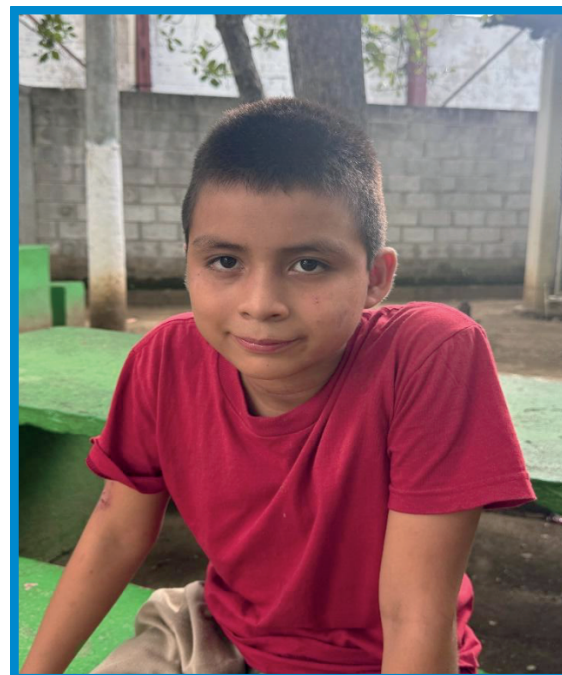

Bryan and his older brother were abandoned by their father. His mother, who is an alcoholic woman, neglected Bryan and his brother. Both brothers suffered from a lot of violence from their mother. One day under the influence of alcohol she beat them. Bryan's older brother suffered several injuries on his body and also Bryan. For that reason now the children are in the custody of the Guatemalan government. Bryan is going through a time of sadness since he does not know anything about his brother, who is in another government home. Bryan has not received visits from any relatives during his time living at the government home. What I have seen is that Bryan has a heart that loves Jesus and that this love of God has slowly been healing his heart. Bryan loves being with us in every activity. He looks for opportunities to be able to help us. We love Bryan's life and I know that God loves him too.
