BETHEL CHURCH MINISTRY FUNDS

Bethel Church has arranged, in addition to giving through normal channels for current ministries, two avenues for major, planned giving, and/or estate gifts:

BETHEL CHURCH FARGO ENDOWMENT FUND

Established in 2019 under the auspices of the North Dakota Community Foundation, this fund allows qualified donors to make endowed contributions and also take advantage of North Dakota's 40% income tax credit. If qualified, a donor can also combine the state savings with federal income tax savings, resulting in a significant financial advantage. See the chart below as an example. Donating appreciated assets, such as stocks or real estate, rather than selling them, can also have tax benefits for donors

Established under the auspices of the Evangelical Free Church of America (EFCA) Foundation, a Ministry Designated Fund is a special charitable fund established to benefit a specific ministry. It is similar to an endowment fund, but both principal and income from the investment may be used in longer-term support of a specific Bethel ministry. The EFCA Foundation manages the funds and makes distributions to Bethel Church.
